1. Commentary - Five Common Myths About Hearing Loss and Hearing Aids

Myth #1: When someone is hearing impaired, that just means that sounds aren't loud enough.

That's just part of it. Many people who have hearing loss have trouble hearing in crowds or group conversations. They hear but don't always understand what is being said due to decreased ability to hear some consonants. For example, "cat", "fat" and "bat" may all sound alike. Words may also seem to be mumbled or just run together. These are but a few symptoms.

Myth #2: Hearing aids are large and ugly.

Most people aren't aware of the latest technological advances that have been made in hearing aids. For many, "completely in the canal" hearing aids are appropriate and are amazingly small and discreet. They're so technically advanced that they have made most old-fashioned hearing aids obsolete

Myth #3: Wearing a hearing aid is a sign you're getting old.
Although hearing loss is more common in older adults, many middle age and younger people are affected as well. There are many determining factors beyond just age. Statistics indicate that of the 28 million people with hearing loss in the United States there are close to 8 million people in the United States between the ages of 18 and 44 with hearing loss, and more

than one million are school age. Remember, a hearing loss is more noticeable than a hearing aid; you just might be surprised to learn that someone you don't expect is wearing a hearing aid. Myth #4: I've heard that my type of hearing loss can't be helped. Nearly 95% of individuals with hearing loss can be helped through amplification. Now there is hope for those who have been told they couldn't be helped. New technologies emerge every year, so you may now be able to be helped when just a few years ago you were told you couldn't. Examples include people with loss in one ear, people with "nerve deafness" or "nerve damage", or individuals with high frequency loss. Myth #5: If I had a hearing loss, my physician would have told me. This may not be the case. Only 16% of physicians routinely screen for hearing loss during a physical. And since most visits are in the quiet of an office visit, it may be virtually impossible for your doctor to recognize your difficulty with hear ing.

Every year EAC offers free hearing screening by one of our audiologist in Everett, once again Lisa MacKay is offering to do this year. The screening will take place from 11:00 to 1:00, we also will be having a demonstration of listening devices, alerting devices, and many more thing that help us with our hearing loss, some of these things are what a hearing aid can't do for those that need more help than a hearing aid.

Auditory System

Outer ear

The external Ear consists of the auricle and the external ear canal. These structures collect the sound waves and transmit them to the eardrum.

Middle Ear

The middle ear lies between the ear canal and the inner ear. This chamber contains the ear drum and three ossicles: the malleus, the incus and the stapes (hammer, anvil and stirrup). Vibrations of the eardrum are transmitted across the middle ear **Continued on page 3**

ear space by these three small bones. Piston-like movement of the third bone (stapes or stirrup_results in fluid waves in the inner ear.

The middle ear chamber is lined with a type of membrane similar to the lining of the nose, which contains secreting and tortuous channel called the Eustachian tube. This passageway serves to equalize of pressure between the middle ear space and the outside atmosphere, as evidenced by the popping sensation noted in the ear during altitude changes

Inner ear (Cochlea)

The inner ear is enclosed in a bony capsules and contains fluid and over 30,000 tiny hair cells. It is lined by a delicate transparent membrane and is supplied by microscopic blood vessels. In this small capsule, fluid waves resulting from movement of the stapes bend the hair cells, which in turn transform the sound waves into electrical signals, and then into nerve impulses in the fibers of the hearing nerve.

NCRA Introduces Communication Access Information Center to help People that are Deaf or Hard-of-Hearing Obtain Cart Services. (Vienna, VA, August 27th, 23002) _ The national Court Reporters Association has launched a new Web site for consumers of Communication Access Realtime Translation (CART) services. www.Cartinfo. org

CART (Communication Access Realtime Translation) technology, also known as realtime captioning, can help person who are deaf or hard-of-hearing to fully participate in such activities as conferences, religious services, education classes and seminars or medical appointments. CART providers accompany people who are deaf of hard-of-hearing to meetings and many other events, and, using a stenotype machine and a laptop, instantly transcribe the spoken words into text that a person with hearing loss can read on a laptop computer or other screen.

"The demand for CART has grown tremendously in the last few years, driven primarily by the American with Disabilities Act, which recognizes CART as an assistive technology that affords effective communication access," said Laurel Eiler, president of the National Court Reporters Association NCRA). "We created this Web site because many times the institutions, organizations

and companies that are required to ensure communication access for people who are deaf of hardof-hearing don't understand the benefits of CART or how to obtain it."

To be and/or not to be Totally Deaf.....

When I first joined SHHH 10 years ago, I have learned a lot, and one of the things that I heard and learned about was Cochlear Implant,, at first I said to myself there is no way anybody going to do surgery inside my head !!!!!!, Well guess what.....

I did !!!!! I had my implant done on July 26th, and August 26 is when I had my first Stimulation with Robbi Bishop at Virginia Mason, Dr. Douglas Backous did my surgery......I have over the years seen people get the surgery and hear all the stories from each one of them their experience with Hearing Loss and having a cochlear implant. I have also witnessed seeing the before and after the surgeries, and it is truly remarkable.... I also knew that my time was near to have this done, my Db were 95 in my Left ear and 97 in my right ear., so ultimately I had to make some choices.....and I felt comfortable and am real pleased with how my surgery went......I had my ears check about 3 yrs ago, and my then audiologist said I do really well with my Hearing aids.....But then in December of 2001, I decided to go to Listening for Life, whereas they are more familiar with, rather I was a candidate or not for the Cochlear.... after several very simple testing, I was assured I was a candidate, and YES the testing they do there is far different then going to a regular audiologist.....

We each have a choice and learn

from SHHH what we want to accomplish and my choice was to be able to hear some sounds even if it is not 100 per cent perfect...

Give yourself a 5 minute hearing test:

- 1. I have a problem hearing over the telephone.
- 2. I have trouble following the conversation when two or more people are talking at the same time.
- 3. People complain that I turn the TV volume too high.
- 4. I have to strain to understand conversations.
- 5. I miss hearing some common sounds like the phone or doorbell ringing.
- 6. I have trouble hearing conversation in a noisy background such as a party.
- 7. I get confused about where sounds come from.
- 8. I misunderstand some words in a sentence and need to ask people to repeat themselves.
- 9. I especially have trouble understanding the speech of women and children.
- 10.I have worked in noisy environment (assembly lines, jack hammers, jet engines, etc.)
- 11. Many people I talk to seem to mumble (or don't speak clearly).
- 12.People get annoyed because I misunderstand what they

Telecommunications Access Service

Anyone in WA State with a hearing loss (hearing aids or not) is eligible to receive either an amplified phone, Voice Carry-Over Phone, TTY, and/or telephone signaling equipment. Fee is based upon income and is less than retail. A trainer sets up and provides training.
